Dear Adjutant Stokes:

The Constitution and Bylaws for PFC John C. DeMarr, Jr. Memorial Chapter #36, Department of Maryland is hereby approved as of this date, with the following changes.

Article V, Section 1 of the Chapter Bylaws must be amended to comply with Article 9, Section 9.2, Para. 1 of the National Bylaws. The Chapter's Bylaws should read: "*Members may participate virtually in general membership meetings of the Chapter. The active membership status of any member participating virtually must be validated at the beginning of each meeting and documented in the Chapter's meeting minutes. Voting during the election of Chapter officers is limited to in-person participation and will not permit virtual participation by members. There shall be no form of voting by proxy or by absentee ballot. Members who experience difficulty, or who are unable to connect virtually, for whatever reason, will not have any recourse to challenge prior decisions made during the Chapter meeting.*" The Chapter will also need to identify which virtual platform (Zoom, GoTo Meeting, Microsoft Teams etc.) it will use to host the virtual participation of its members and document such in the Chapter's Bylaws. The Chapter itself will be responsible for purchasing equipment necessary to facilitate virtual participation by members at the Chapter meeting and shall not purchase equipment, services, and subscriptions for individual members to use.

The following must be added to the Chapters Bylaws: "*To the extent to which any of the provisions of this Constitution and Bylaws are, or may at any time become, inconsistent or in conflict with the provisions of the Constitution and Bylaws and lawful mandates, decisions and regulations of either the National Organization, as now in force or as hereafter amended or adopted, this instrument shall be deemed amended as to conform thereto.*" P-12.

There is a page break where the Bylaws end and the signature page begins, which must be removed to prevent further additions to the Constitution and Bylaws after they have been signed and executed.

A copy of this document is being returned to Chapter #36 along with a copy to the Department. A copy is also being retained in our permanent files here at National Headquarters for future reference.

**CONSTITUTION
ARTICLE I - NAME**

Section 1: The name of this Chapter shall be Disabled American Veterans, PFC John C. DeMarr, Jr. Memorial Chapter No. 36.

Section 2: The name of this Chapter of the Disabled American Veterans (DAV) must not be used in connection with, nor shall the Chapter enter into or engage in, any political, sectarian, or labor dispute, nor in any matter not directly relating to wartime service-disabled veterans. However, nothing in this section shall prohibit this Chapter from participating in political issues which have a direct bearing on the welfare of America's Disabled Veterans.

ARTICLE II - PURPOSE

The purpose of this Chapter is keeping our promise to American Veterans who served, and, in furtherance of that purpose, to support the programs of the Disabled American Veterans as provided in the National Constitution and Bylaws and the Regulations of the National Executive Committee.

ARTICLE III - MEMBERSHIP

Membership in this Chapter shall conform to the requirements as set forth in the National Constitution and Bylaws. There shall be no associate, special or honorary memberships in this Chapter.

ARTICLE IV - ADMINISTRATION

Section 1: The administrative affairs of this Chapter shall be vested in the Chapter Executive Committee in emergencies only, and all other actions of the Executive Committee must be ratified by a majority vote of the Chapter members present and voting at the next regular Chapter meeting.

Section 2: At the time specified in the Chapter Bylaws, the Chapter shall elect annually a Commander, Senior Vice Commander, Junior Vice Commander (not to exceed three), Treasurer, and Chaplain.

Section 3: The appointed officers of the Chapter shall consist of the Adjutant, Historian, Service Officer(s), Judge Advocate, Sergeant-At-Arms, and Officer of the Day who shall be appointed by

the Commander with the approval of the Chapter. Such other officers as may be necessary to operate the Chapter may be appointed by the Commander, with the approval of the Chapter. Neither the Chapter Commander nor any Chapter Vice Commander shall serve as Chapter Adjutant or Treasurer.

Section 4: The Executive Committee shall be composed of the Commander, Senior Vice Commander, Junior Vice Commander(s), Treasurer, Chaplain, Adjutant and Judge Advocate.

Section 5: The Commander, Adjutant, and Treasurer shall at all times be bonded and such bond premium is to be paid for by the Chapter in accordance with the National Bylaws.

ARTICLE V - EXECUTIVE

The executive power of this Chapter shall be vested in the Chapter Commander.

ARTICLE VI - AUXILIARY

The Chapter recognizes a DAV Auxiliary, subject to such supervision as conforms to both the National and Department Constitution and Bylaws.

ARTICLE VII - AMENDMENTS

This Constitution may be amended at any Chapter meeting by a two-thirds vote of Chapter members present and voting, subject to approval of both the Department and National Judge Advocates, and effective only after the date of said approval, provided that any such amendment is read at two (2) meetings and that Chapter members were notified of the proposed change prior to each of the (2) two meetings.

BYLAWS

ARTICLE I - ORGANIZATION

Section 1: This Chapter recognizes the National Organization known as Disabled American Veterans (DAV), incorporated by an Act of Congress and affirms its allegiance and subordination to the National Organization, its Constitution, Bylaws, and all rules, mandates and regulations promulgated pursuant thereto. Upon dissolution of the Chapter, the assets remaining after the payment of its debts shall be distributed as provided in Article 6, Section 6.4, Paragraphs 5, 6 and 8, of the National Bylaws.

Section 2: The governing body of this Chapter shall be the Chapter in session, except as provided in this Constitution and Bylaws.

Section 3: Minutes of the meetings of the Chapter, including Chapter Executive Committee, shall be kept and be available for inspection by any Chapter member.

ARTICLE II - CHARTER

The Charter of this Chapter, issued by the National Executive Committee, is its authority to function and shall be displayed at the Commander's station at all regular meetings.

ARTICLE III - MEMBERSHIP

Section 1: No new applicant shall be denied Chapter membership if he or she meets the eligibility requirements as set forth in the National Constitution and Bylaws.

Section 2: Only members of the Chapter are eligible to vote on any motion or at any election.

Section 3: Members of another Chapter may secure a transfer of membership to this Chapter with the approval of the membership of this Chapter.

Section 4: The membership year shall commence on July 1 and expire at midnight of the following June 30. Dues shall not be apportioned or prorated.

Section 5: Dues in this Chapter shall be as the National Organization directs.

Section 6: All disciplinary actions taken or commenced against members or officers shall be in accordance with Article XVI of the National Bylaws.

Section 7: Each member accepting or retaining membership in this Chapter agrees to be bound by the Chapter's Constitution and Bylaws, the Department Constitution and Bylaws, and DAV National Bylaws, now in force or hereafter adopted or amended.

ARTICLE IV - OFFICERS

Section 1: Elected Officers

Paragraph 1: The Chapter shall elect annually a Commander, Senior Vice Commander, Junior Vice Commander (not to exceed three), Treasurer, and Chaplain.

Paragraph 2: A member shall hold only one elected Chapter office at any one time. A delegate to a National or Department Convention or Department Executive Committee is not an "elected officer" within the meaning of this Section. Except as otherwise provided herein, an elected officer may also hold an appointed office, and vice versa, except the Chapter Commander and Vice Commanders shall not serve as Chapter Adjutant or Treasurer.

Paragraph 3: Any person who is a member of this Chapter shall be eligible for any elected or appointed office in this Chapter, except as otherwise provided in this Constitution and Bylaws.

Paragraph 4: Upon the election, or appointment, and the installation of the successor to any office, all Chapter property in the possession of the predecessor shall be surrendered to the newly installed officer.

Paragraph 5: A Chapter Officer Election Report shall be submitted by the Adjutant to the Department of Maryland and the National Organization within ten (10) days after the installation of newly elected or appointed Chapter Officers or in the event of any subsequent change in the Chapter Officers during the membership year. A Department of Maryland Chapter Supplemental Report shall accompany the Chapter Officers Election Report submitted to the Department.

Section 2: Duties of Elected Officers

Paragraph 1: The Commander shall preside at all regular or special meetings of the Chapter. The Commander shall maintain order and dispatch such business as may legally come before the Chapter. All checks or vouchers issued by the Chapter Treasurer shall be co-signed by the Commander or the Adjutant in the absence of the Commander. The Commander shall perform all other duties that may reasonably be assumed to be incidental to the office held, including those set forth in this Constitution and Bylaws and in the Official DAV Ritual, and such other duties as may be lawfully delegated by the Chapter.

Paragraph 2: The Senior Vice Commander, Junior Vice Commander, Treasurer, and Chaplain shall perform the duties of the Commander in the order named in the event of the Commander's absence. If the Commander should die, resign or be removed from office, the same order of authority shall be in effect until the next Chapter annual election.

Paragraph 3: The Senior Vice Commander shall perform the duties of his or her station as set forth in the Official DAV Ritual. The Senior Vice Commander shall encourage friendship among the members of this Chapter, discourage discord, and promote harmony. The Senior Vice Commander shall serve as chair of the Membership Committee. The Senior Vice Commander will provide monthly membership reports. He/She will also serve as the chapter new members' orientation mentor.

Paragraph 4: The Junior Vice Commander(s) shall perform the duties of his or her station as set forth in the Official DAV Ritual. The Junior Vice Commander(s) shall assist with publicity, public relations, and Chapter fundraising activities as approved by the Chapter. This Chapter shall not sponsor or engage in, directly or indirectly, any fundraising or finance project without the prior approval of the Department of Maryland. The Junior Vice Commander(s) shall also be responsible for obtaining guest speakers for Chapter meetings and special events. The Junior Vice Commander will be the Local Volunteer Assistance Program coordinator.

Paragraph 5: The Treasurer shall receive and immediately deposit all Chapter funds in a bank account in the name of the Chapter without any deductions or offsets. The Treasurer shall make authorized disbursements only by checks signed by the Treasurer and co-signed by the Commander or Adjutant. No disbursement of Chapter funds shall be made without a completed Chapter voucher along with attached receipts. The Treasurer shall render a monthly report of receipts and expenditures to the Chapter at each regular Chapter meeting. The Chapter's accounting/fiscal year is July 1 to June 30. The Treasurer shall serve as Chair of the Budget and Finance Committee and shall prepare a budget for presentation to the Executive Committee and the membership at the respective May meetings for review, then for approval by the membership at the June meeting. The Treasurer's financial records shall be made available for audit on an annual basis, and an annual financial report shall be submitted to the Department of Maryland and National Organization, if required, within ninety (90) days after the close of the accounting year of the Chapter. This report shall have been audited and approved by the Chapter Audit Committee. The Treasurer is responsible for filing the appropriate IRS 990N document annually according to its financial status no later than (NLT) November 15th and Maryland Form 1 by April 15th. All motions for expenditures of items not included in the budget shall be referred to the Budget and Finance Committee for its recommendations.

Paragraph 6: The Chaplain shall perform the duties of the Chaplain's station as set forth in the Official DAV Ritual. The Chaplain shall visit the sick and comfort the families of those members who are called to the Great Beyond. The Chaplain is responsible for encouraging attendance at DAV conducted funerals and the proper conduct thereof. The Chaplain shall also serve as Chair of the Welfare Committee with the approval of the Chapter, may appoint one or more members to assist, as appointed.

Section 3: Appointed Officers

Paragraph 1: The Commander shall appoint, subject to the approval by the Chapter, the following officers:

Adjutant, Historian, Service Officer(s), Judge Advocate, Sergeant-at-Arms, and Officer of the Day.

Paragraph 2: The tenure of appointed officers shall be at the pleasure of the appointing power, provided that no term of office shall exceed that of the appointing power, except as otherwise expressly provided for elsewhere in these Bylaws.

Section 4: Duties of Appointed Officers

Paragraph 1: The Adjutant shall keep a true and complete record of all business meetings conducted by the Chapter, including the Minutes of each Chapter and Executive Committee meeting. The Adjutant shall conduct all necessary correspondence, keep an up-to-date list of the Chapter's membership of both current and former members. All motions approved by the Chapter shall be recorded along with the name of the member who made the motion (the name of the seconder is not required), and the resulting vote. The Adjutant shall ensure that all Delegates going to the Department and National Conventions have proper credentials and is responsible for forwarding the Delegate names to the Department and National, respectively.

Paragraph 2: The Historian shall keep a brief history of the activities of the Chapter to be kept as a permanent record of the Chapter. The Historian shall serve as the Chapter's Publicity Officer and shall regularly furnish proper publicity materials to local newspapers, radio stations, and the official DAV National and Department newspapers with approval of the Commander. No other member shall cause any publicity to be given to the Chapter and its activities without the approval of the Commander.

Paragraph 3: Chapter Service Officer(s) shall advise and assist any veteran and their dependents in the preparation and processing of their claims for veteran benefits from the Department of Veterans Affairs.

Paragraph 4: The Judge Advocate shall serve as the Chapter's Parliamentarian and shall possess a working knowledge of Robert's Rules of Order Newly Revised (RONR). The Judge Advocate serves as chair of the Constitution and Bylaws Committee and serves in the capacity as a consultant that advises the Commander, officers, Executive Committee, and Chapter members on matters of parliamentary procedure. The Judge Advocate, upon the request of the Commander, shall render an opinion on all parliamentary questions, any question arising out of any dispute on floor of the assembly, or the interpretation of the Chapter's Constitution and Bylaws or the Constitution and Bylaws of the National and Department organizations. Upon receipt of the Judge Advocate's opinion, the Commander or presiding officer shall announce their ruling or decision, which need not be in accordance with the opinion of the Judge Advocate. Such decision shall be final and binding upon the Chapter unless overruled by a two-thirds vote of the members at the meeting during which the decision is announced.

Paragraph 5: The Sergeant-at-Arms shall perform the duties of their respective office as set forth in the Official DAV Ritual.

Paragraph 6: The Officer-of-the-Day shall perform the duties of their office as set forth in the Official DAV Ritual. The Officer-of-the-Day shall welcome all visitors and see that each is properly introduced.

ARTICLE V – MEETINGS

Section 1: ~~The regular monthly meeting of this Chapter shall be held on the third Tuesday of each month at 7:00 PM at The Jaycees Community Center, Waldorf, Maryland, as designated by this Chapter or at such other time and place as designated by the Commander after due notice has been given to the membership in writing. All regular membership meetings, executive committee meetings, and other committee meetings may be held electronically so long as all members can simultaneously hear each other and participate during the meeting. Members participating virtually must be validated at the beginning of each meeting and documented in the minutes. Validated means the Adjutant, Senior Vice Commander or Sgt at Arms should personally know the person is a DAV member or have the Chapter Roster on hand to be able to verify that the person is a member.~~

Section 2: Emergency or Special meetings may be called by the Commander whenever deemed necessary or when requested in writing to do so by ten or more Chapter members. The call for such meetings shall include the date, time, and place of the meeting and state the business to be transacted. Such notice shall be given in such manner as to reach members at least forty-eight (48) hours in advance of the time set for the meeting.

Section 3: The annual meeting for the election of officers shall be in person.

Section 4: In instances of bad weather or some other emergency that makes traveling to the meeting site difficult, the Commander may cancel or change a meeting with four hours (4) advance notice. The Commander may reschedule a meeting with a new date/time and method to be determined within forty-eight (48) hours.

Section 5: A quorum shall consist of seven (7) members, of which, at least two (2) must be elected Chapter officers.

Section 6: The full official DAV Ritual shall be observed at every Chapter meeting. All members shall be encouraged to purchase and wear the official DAV lapel emblem and uniform hat. Wearing of ball caps at chapter meetings is discouraged.

Section 7: No visiting member, with the exception of Department or National Officers, shall speak on any subject under debate without the permission of the Commander or the approval of the Chapter by majority vote.

Section 8: Unless circumstances mandate, meetings will not be held during the months of July and August.

Section 9: Discussion of personal grievances will not be in order on the floor unless introduced by the Chaplain or committee having the authority to consider any such matters.

Section 10: Matters concerning only an individual member, with respect to his or her own personal interest, shall not be in order but may be taken before the proper committee.

ARTICLE VI - EXECUTIVE COMMITTEE

Section 1: The Chapter Executive Committee shall be composed of the Commander, Senior Vice Commander, Junior Vice Commander(s), Treasurer, Chaplain, Adjutant, and Judge Advocate.

Section 2: Meetings of the Chapter Executive Committee will be called by the Commander or at the request of the majority of its members made in writing to the Commander. Other members of the chapter may attend these meetings without a vote.

Section 3: A majority of the Chapter Executive Committee members shall constitute a quorum.

Section 4: The Chapter Executive Committee may act on behalf of the Chapter during the period the Chapter is not in session.

Section 5: All fundraising projects and all agreements and contracts shall be referred to the Chapter Executive Committee for its recommendations before being acted upon by the Chapter. All non-standard fundraising projects (excluding Golden Coral and Forget Me Not) agreements and contracts are approved by the Department and DAV National Executive Committee.

Section 6: In the event the Chapter Executive Committee fails to make recommendations upon any matter referred to it within 45 days, the Chapter, by majority vote, may act upon such matter without receiving the recommendations of the Committee.

ARTICLE VII - NOMINATIONS AND ELECTIONS

Section 1: The Chapter shall elect a Nominating Committee during the January meeting. The committee shall consist of no more than three (3) Chapter members who shall identify qualified nominees for each elected position and report its findings at the February membership meeting. After the nominees are presented to the body, the Commander will take nominations from the floor.

Section 2: A member nominated for office shall accept or decline the nomination. If a nominee is unable to appear in person, the nominee may accept or decline in writing to the Adjutant prior to the March election. If a nominee fails to accept or decline the nomination as set forth above, the nomination shall be deemed and constituted to be declined and the name of the nominee shall be stricken from the ballot.

Section 3: Nominations and elections of officers shall be made in the order of the officers prescribed in Article IV, Section 1 of the Bylaws, and one nominating and one seconding speech may be permitted for each candidate at the March election.

Section 4: At the March membership meeting, the Chapter shall elect members to represent the Chapter on the Department Executive Committee. In accordance with Article 3 of the Department of Maryland Constitution and Bylaws, each chapter is entitled to three (3) Department Executive Committee representatives (DECs) and three

(3) Alternate Department Executive representatives (ADECs). Names and addresses of the persons elected must be submitted to the Department thirty (30) days before the Department Convention convenes.

The Chapter may provide financial assistance for the Commander and at least one Delegate (pending budget limitations) to attend meetings of the Department of Maryland Annual Convention, 6th District National Executive Committee, National Mid-Winter Conference, DAV National's Annual Convention. Reimbursement to be paid based on mileage or economy flight ticket cost (whichever is lowest), lodging, and per diem as established by US Government rates for the area of travel. All applicable receipts shall be submitted along with vouchers for reimbursement. Reimbursements will be submitted to the Chapter Adjutant no later than (10) days after the month of authorized travel is completed.

Section 5: The officers shall be elected by ballot. When there is only one candidate for an office, the candidate may be elected by acclamation.

Section 6: There shall be no voting by proxy or absentee ballot.

Section 7: The presiding officer can vote as any other member when the vote is by ballot. In all other cases, the presiding officer can (but is not obliged to) vote whenever the vote will affect the result; that is, to vote either to break or to cause a tie. In the case where a two-thirds vote is required, the vote can be made to either cause or block the attainment of the necessary two-thirds.

Section 8: All nominations for either Department or National Convention delegates shall be made at the meeting preceding the meeting at which they are to be elected. Election for National Convention delegates shall be held not less than sixty (60) days preceding the opening date of such convention.

ARTICLE VIII - COMMITTEES

Section 1: Standing Committees

Paragraph 1: The standing committees of the Chapter, in addition to those otherwise provided for in this Constitution and Bylaws shall be: Membership Committee, Welfare Committee, Budget and Finance Committee, Audit Committee, Legislative Committee and Constitution and Bylaws Committee. The Commander will be an ex-officio member of all standing committees.

Paragraph 2: The Commander, except as otherwise expressly provided in this Constitution and Bylaws, shall appoint and designate the Chair of each Standing Committee. The Commander, by virtue of office held, shall serve as an ex-officio member on all committees except the Nominating Committee.

Paragraph 3: The Membership Committee shall be responsible for all matters pertaining to the membership of the Chapter, including recruitment, and reinstatement. This committee is chaired by the Senior Vice Commander and shall also have two (2) or more members as appointed.

Paragraph 4: The Welfare Committee shall contact chapter members that are sick and shut in, comfort families in mourning, encourage attendance at members funerals, keep informed of the public and private agencies and organizations that can offer temporary or permanent assistance to disabled veterans or their

dependents and to assist such persons in securing proper and adequate aid and assistance. This committee is chaired by the Chaplain and have at least one (1) additional member as appointed.

Paragraph 5. The Budget and Finance Committee shall be chaired by the Treasurer. This committee shall prepare the annual budget for presentation to the Executive Committee at the May Executive Committee meeting for input and review. The proposed budget shall be submitted to the body at the May general membership meeting and for input and review for approval at the June general membership meeting. The Chapter's accounting/fiscal year is July 1 to June 30. The Budget and Finance Committee shall also ensure the annual budget includes provisions for attendance at National and State conventions/conferences, and the Commander's discretionary fund not to exceed \$300.00, based on the availability of Chapter operational funds (Forget-Me-Not funds are restricted, they will be used specifically to support needy veterans and spouses). The following funds are not restricted: Membership Funds from DAV National, Funds raised from Fundraisers, and Donations. The chapter will not accumulate funds in excess of three times the expenses of the last fiscal year (ref National Bylaws, Article 18, Sect 18.2).

Paragraph 6. The Audit Committee shall be composed of at least three (3) Chapter members excluding the Commander, Senior Vice Commander, Junior Vice Commander(s), Treasurer and Adjutant. The Audit Committee is responsible for conducting an annual audit of the financial records maintained by the Treasurer after the close of the accounting/fiscal year. The Audit Committee shall present a report of the audit results and any accompanying recommendations to the body.

Paragraph 7. The Legislative Committee is responsible for monitoring and reporting on national, state, and county legislation that affects the well-being of Veterans and their families.

Paragraph 8. The Constitution and Bylaws Committee is responsible for ensuring that the Chapter's constitution and bylaws are consistent with the constitution and bylaws of the National Organization and the Department of Maryland. All proposed amendments and changes to the constitution and bylaws shall first be reviewed by this committee. This committee shall then present all proposed amendments and changes to the Chapter members for input and review after the second reading, and then to the membership for adoption at a regularly scheduled meeting. This committee is chaired by the Judge Advocate and shall also consist of as many appointed members as deemed necessary.

Section 2: Other Committees

Such other committees, special or ad hoc, as may be deemed necessary to carry on the work of the Chapter shall be appointed by the Commander with the approval of the Body.

ARTICLE IX – BEQUESTS

All bequests and/or other testamentary gifts like IRAs, bank accounts and life insurance policies regardless of size, type, or designation must be submitted to the Bequests Reporting Program (BRP) to ensure distribution is pursuant to the donor's intent. Chapters are required to promptly report bequests upon notification or receipt, by submitting an image of all paperwork received to legaldepartment@dav.org.

ARTICLE X - PARLIAMENTARY AUTHORITY

The rules contained in Robert's Rules of Order Newly Revised (RONR) shall govern the Chapter in all cases to which they are applicable and in which they are consistent with this Constitution and Bylaws, and the Constitution and Bylaws of the Department of Maryland and the National organization.

ARTICLE XI - AMENDMENTS

Section 1. These Bylaws shall not be effective until adopted by a two-thirds (2/3) vote of the Chapter members present and approved by the Department of Maryland Judge Advocate, and the National Judge Advocate.

Section 2. These Bylaws may be amended only by having the proposed amendment(s) submitted and read at two meetings and adopted by a two-thirds (2/3) vote of the membership present at the next regular meeting. No amendment shall become effective until approved, as provided, in Section 1 above.

Section 3. Wherever these Bylaws or subsequent amendments may be found to conflict with the present or any future Department or National Bylaws, the latter shall prevail and be binding upon this Chapter as though written herein.

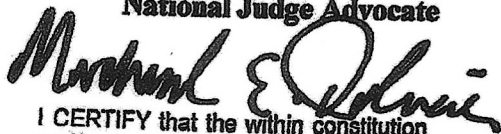

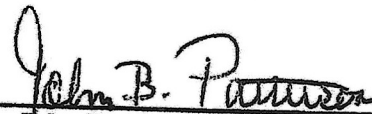
